

# Public Information Meeting for the US-14 (Euclid Ave.) Reconstruction Planning Study Project No.NH 0014(185)229, PCN026Z

Thursday, June 1, 2017 5:30-7:00pm • RedRossa Banquet Room • 808 W. Sioux Ave. Pierre, SD

The purpose of today's meeting is to present initial improvements proposed for US-14 Euclid Avenue, to answer your questions and receive comments.

The South Dakota Department of Transportation in cooperation with the City of Pierre and the Federal Highway Administration plan to reconstruct 1.7 miles of US-14 (Euclid Avenue) located in the City of Pierre in Hughes County, starting at the intersection of Sioux Avenue and Pierre Street north to the divided section just west of the junction of State Highway 1804. The existing roadway on this segment of US-14 generally consists of four 12-foot wide driving lanes with left turn lanes at some major street intersections.

US-14 (Euclid Avenue) in Pierre reconstruction would consist of removing the existing concrete base (and areas of overlaid asphalt) and replacing with new concrete pavement.

## **Project Purpose and Need**

#### The purpose of the proposed project is to:

- Maintain the pavement infrastructure
- Improve the safety for all road users
- Reduce driver delay

The project aims to provide an improved roadway corridor for vehicular, bicycle, and pedestrian travel.


#### The need for the proposed project

is based on the distressed nature and poor condition of the roadway. The paved roadway has deteriorated over the last 50+ years and is beyond the end of its anticipated life.

In combination with the proposed roadway reconstruction, SDDOT and the City are in the process of evaluating whether the corridor would benefit from additional improvements. SDDOT and the City would like your input regarding the following topics and improvements that may be considered:

- Pedestrian & Bicycle access
  - Construct new ADA compliant facilities
- Vehicle access and circulation issues
  - Extend and/or add turn lanes
  - Consolidate and/or modify access drives
  - Update traffic signals
- Address Parking needs and/or concerns
- Drainage concerns
  - Reconstruct storm sewer and/or curb inlets
  - Upgrade under-pavement utilities

Your input is important to the development and success of the planning study.



### How will the SDDOT proceed after the initial public information meeting?

The purpose of meeting is to engage stakeholders early in the planning process enabling transportation officials to make informed decisions. The project team will review public input to identify additional project needs and design components as well as potential impacts going forward.
